### Constituency Leaders Council

The CLC (Constituency Leaders Council) met in Colorado Springs on October 15-17th. As usual the agenda was very full. Our conversations included several major issues we are prioritizing as a denomination.

Anti-Racism continues to be a complex, emotional issue. As a test, the CLC was segregated into table groups of racial/ethnic, women, and Anglo men. The meeting dynamic changed. During a discussion on racial/ethnic issues, the 'white' male tables struggled, while the women and racial/ethnic groups engaged quickly. Frankly, I was uncomfortable. This is an issue that I need to listen to others, not propose solutions. As a white middle aged, middle class male, in a rural village, my awareness around racial/ethnic issues is limited. I think my table felt the same way. We need to learn. There continue to be strong emotions around this topic, but my sense is that there is good faith in what needs to be done.

LeRoy and I both came away from this meeting a bit troubled. New York has most certainly become more homogeneous over the last decade, and our urban presence has diminished. This priority can be very interesting if we get serious about it.

We were also made uncomfortably aware of the movement by CLC toward unequal male/female representation. Women currently make up less than one in five CLC representatives. This is troubling, and was also a mirror for us in New York. We've only ever had male representatives to CLC and our Coordinating Council has only briefly had more than one female on it at any given time, until now.

Coming out of San José, the Health-care Access Action is a hot topic. In light of obvious brokenness in the health care system of the United States, and its resulting inequities, Mennonite Church USA is starting with a modest initiative. Can we form a true mutual aid program that offers health care coverage for all pastors of MC USA? This connects with issues of immigration, inequities along racial/ethnic lines, and affordability by hundreds of small congregations staffed by part time or volunteer pastors. CLC has been a major contributor to this conversation as it continues to move forward. A major question remains... do we still carry a vision for Mutual Aid?

At San José, the beginning of a new dialogue emerged. What are the lines of authority that Conferences have regarding discipline of congregations which diverge from confessional norms in issues of faith and life? Should conferences carry this authority, as we relate within an organizational structure? The discussion was vigorous and will be on-going.

I left this gathering with a sense of unity. On the second day, when meeting weariness usually sets in, I noticed how easily we were able to laugh together. The stress, even in the midst of thorny questions, was low. The sense was that we can work and worship together. LeRoy and I agreed that it was the best CLC we've attended yet. Our next gathering is March 31 - April 2 down in Laurelville, PA.

## Pleasant Valley: Moving Next Door

In December Pleasant Valley Mennonite finalized sale of its original church property, including the building. But its move was a short one.

Nearly 50 years ago the church purchased the disused Pleasant Valley School and used it for meetings. When that building burned, members erected a purpose-built church facility.

The school/church ground was part of a tract donated in 1795 by land agent Charles Williamson, for school and cemetery use. When the Mennonites entered the picture the school part of the parcel was subdivided, with the other half going to the Moose Lodge.

When the Moose Lodge finally disbanded, their building became a restaurant—when the restaurant closed, the church bought it, reuniting the subdivided segments. They named the new facility Pleasant Valley Celebration Hall.

It soon became clear that the Celebration Hall (all on one level) was better suited for a 21st-century church facility, especially with an aging congregation. The old church was mothballed to save expenses, and will now become a private home and boat shop.

Colonel Williamson's hopes 212 years ago are still being fulfilled, with Pleasant Valley Cemetery and Pleasant Valley Mennonite Church still serving the community.

## Clarence Center: Mental Health Support Group

Clarence Center is starting a support group for people struggling with depression, anxiety, bipolar disorder, and other mental health issues—either their own, or those of a friend or loved one. It will be a way for members to receive encouragement and to realize that they are not the only one in our congregation dealing with such difficulties. This group is forming in response to the interest generated out of the church's recent educational courses dealing with mental illness. Sessions will focus on a topic each time, but will have plenty of time for members to hear each others' stories, struggles and victories as we journey together toward healing.

## Lowville

### Sewing Circle Gathers a Bundle

In November the Faithful Workers Sewing Circle sewed five baby layettes and tied five quilts—four of them 60 by 80, and the other one a twin quilt. They gathered two school kits, six health kits, six knitted and crocheted items, 6 3/4 yards of fabric, three pounds of used clothing, six Christmas bundles, and \$190, in addition to 26 relief kits from the church.

### Lowville Volunteer in Vietnam

Since 1997 Donna Zehr Keener and her family have been serving in Ho Chi Minh City (formerly Saigon), Vietnam. Donna, who grew up in the Lowville congregation, teaches in the Saigon South International School. They went to Vietnam through Eastern Mennonite Missions, and now Mennonites have been licensed to operate throughout the country, giving them more opportunities for church leadership development.

Donna reports that Christmas in Vietnam is in many ways like Christmas in the US—commercial frenzy, heightened devotion, and new opportunities to tell the Gospel.

### Christocentric Challenge

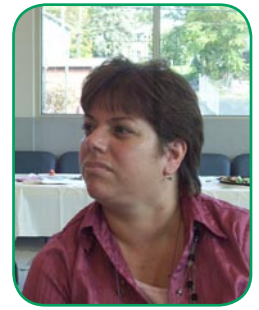
